SUMMARY OF OUR LECTURE MODEL

- We run full 17 to 18 weekend lectures for a diet with comprehensive revision and mock examinations in the last 2 weekends .
- All our online lectures are recorded and access to the recorded videos are shared to our students to support their preparation for the diet.
- We maintain a general WhatsApp platform where general information is being passed to our students while we also maintain a WhatsApp platform for each level where level specific information is passed. We also maintain a public telegram group where anyone writing ICAN examination can join for information.
- We maintain a Google course tracker which enable both Tutors and Students to track the progress of the diet until syllabus is fully covered for each diet.
- We maintain a Google e-library where all your course materials and past questions including NPT lecture materials can be downloaded.
- We provide a course chart (past question map) to enable our students navigate past questions with ease and also leverage on this to identify the trend and pattern at which topics are tested.
- We conduct standard Mock examinations which are carefully set by our Lead Tutors to assess our students' readiness for exam.
- Through a buddy system, we assign accountability partner to each student. This is done by ensuring that each student has a Tutor they are accountable, who also monitor their welfare throughout the diet.

VIDEO POLICY

- a. Our videos are maintained on Google drive and access are shared with students (via Gmail) to support their preparation for the diet. We also share access to lecture videos of the immediate preceding diet to enable our students prepare ahead of the live classes.
- b. The videos are uploaded during the following week after each lecture weekend. The standard is to upload as early as possible to enable students who misses the live lectures to have enough time to catch up before the following weekend.
- c. We do not grant permanent access to videos and access are only valid for the diet which lecture are enrolled and paid for.
- d. Our videos are not available for download and also, students are not expected to share the videos with anyone. We reserve the right to refuse access to videos for anyone who breaches this policy.
- e. Access to video are only shared for courses fully pay for. (Eg: A student writing PM & FR with a part payment that covers our lecture fee up to 1 paper will only have access to 1 course until the balance is paid).
- f. The policy in (d.) above only applies to lecture videos and not the live lectures. A student who has made part-payment shall have access to attend our lectures until lecture is restricted to those with full payment. Deadline for payment for lectures are communicated appropriately from time to time.

REFUND AND ROLL-FORWARD POLICY

- a. Students may choose to make payment for lectures at once or by early planned installment (usually up to 3 installments are allowed).
- b. Student may wish to ask for refund. Full tuition fee shall be refunded if the request is made within 7 days after such payment is made. For any request for refund made after access to recorded videos have been granted and still within 21 days, the team shall review and deduct any amount deemed appropriate for the benefit enjoyed so far. Lecture fees shall become non-refundable 21 days after such payment is made.
- c. Student may wish to roll-forward any payment due to a change of their exam plan. The team shall review this and approve only if the request for roll-forward is made within 6 weeks after lecture commencement. The student shall pay our 'base fee' of N10,000 in the following diet to roll-forward the fee.
- d. Any change of exam plan after week 6 of our lecture is subject to critical review. The team will approve roll-forward only when the student is able to prove beyond reasonable doubt that the change is due to genuine reasons such as pregnancy, childbirth, death of a close family member, sickness or similar reasons. The student shall pay our 'base fee' of N10,000 in the following diet to roll-forward the fee.
- e. Any change of exam plan not considered in (c&d) above shall be fully borne by the student.
- f. Students also are allowed to pay tuition fees for diet following the current diet (E.g: Students planning to write May 2026 diet may wish to pay early and start attending lectures with November 2025 diets students). The student will only be required to pay our 'base fee' of N10,000 to have the fees roll-forward. However, this needs to be communicated at the payment inception and the roll-forward form must be filled.

MOCK EXAMINATION POLICY

- a. As part of our lecture model, all students are expected to participate in our mock examinations to enable them to assess their readiness for the actual ICAN examinations.
- b. Our Tutors invest quality time, analyzing ICAN past papers to identify possible trends, weight of each topics and other important factors to ensure that our mock examinations reflect the expectations from the actual examinations.
- c. Students are expected to treat this mock exams like the actual ICAN examinations and all standards are expected to be followed.
- d. All mock exam attempts are reviewed and feedback are provided to the students and students are expected to be opened to objective feedback to enable them assess their readiness for the actual ICAN examinations.
- e. All solutions are released and mock debrief sessions alongside general revision to enable students close any gap identified during the mock examinations.
- f. After the mock exercise, the mock questions and solutions are made public by uploading in our e-library. This can also be shared with other students preparing to write ICAN examinations.
- g. However, it is important to note that the questions in the actual ICAN examinations may be significantly different from the mock exams.

2	Exemption processing	Students can claim exemptions from writing some papers depending on the course of study. Graduate of accounting, finance, economics, and other business courses are usually entitled to exemptions. <i>See the full exemption guide</i>	We help students to complete the process. Steps: -Students to pay the fee in the exemption guideline plus processing fee of N5,300 to our access bank account above. -Complete our exemption form and upload your documents (Degree certificate and NYSC certificate) via: www.bit.ly/NPT-ICANexemptionform
3	Students' annual subscription	From first year of registration, ICAN students are expected to pay an annual subscription of N6,400 in the first year and N4,400 in subsequent years. This is required to be cleared in any financial year to be able to process exemption or exam.	Students should add a processing of N1,000 to the subscription fee and send along with exemption/exam fee.
4	Exam registration	Students who are dully registered and have claimed exemptions entitled to can go ahead to register for papers eligible and willing to sit for before deadline stipulated in the ICAN advert for the diet.	We help students to complete the process. Steps: -Students to pay the fee in the exam advert plus processing fee of N3,300 to our access bank account. -Complete the exam registration form and upload your passport and signature via: www.bit.ly/NPT-ICANexamform

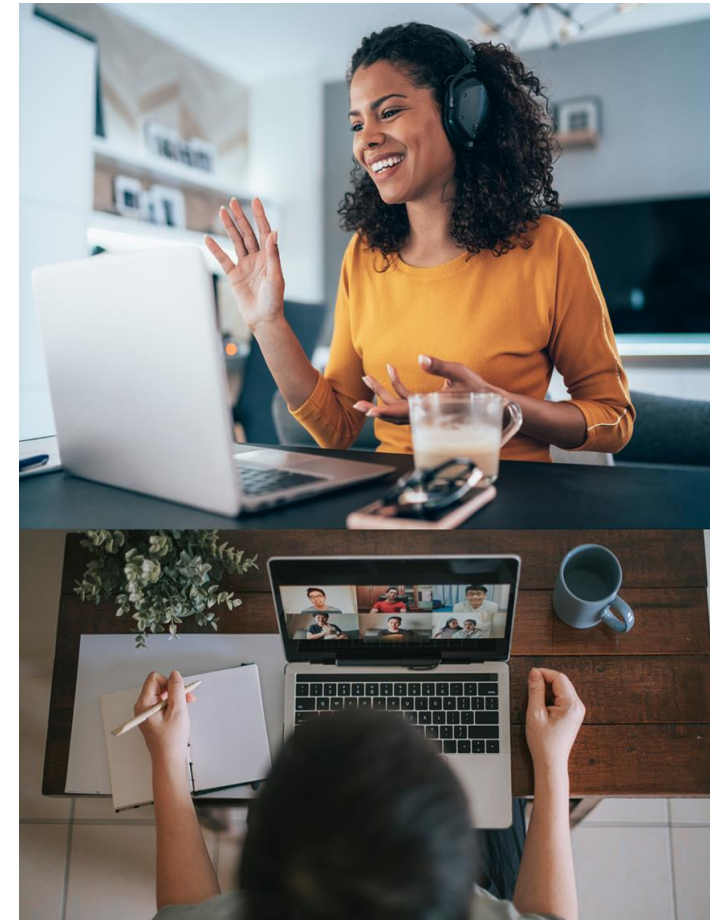
